Works must be appropriately framed, with attached wire for hanging. Weight limit, 40 lbs. Size limit, 42"x42."

Plexiglas is required for works that are shipped and optional for hand-delivered works.

Her work appears in watercolor books and magazines and she is the author of "Pouring Light, Layering Transparent Watercolor" which was released in November 2005 by North Light.

In her workshop, Jean demonstrates the use of poured watercolor washes to create the illusion of light falling on, through and around objects, while at the same time retaining the beauty of the white paper. She creates new and exciting ways to approach the art of watercolor, demonstrating new ways of balancing "chaos" and "control."

Eligibility

Original work only, completed without supervision from idea to execution.

No works previously entered in GCVAA show.

GCVAA reserves the right to refuse any inappropriate or inadequately framed artwork, or artwork misrepresented by entry slide/digital imagery.

Slides with tape or adhesive labels applied to mount will be disqualified. Images on CD must be appropriately labeled. No PHOTOSHOPPING or other digital manipulation permitted.

Entry Procedure

Submit up to four slides or digital images.

Entry fee is \$35/non-members; \$25/members (as of 12/31/09) or workshop participant. Make checks payable to GCVAA.

Include a self-addressed envelope/ mailer for return of slides or CD. Be certain to attach sufficient postage for return mailing.

Entering the competition grants GCVAA permission to publish the images of accepted paintings for publicity on the web and in print.

Digital Submissions

- Digital entries must be in jpeg format on a CD. Set camera resolution at 300 dpi.
- Image size should be no larger than 6" in either direction.
- Image must be oriented correctly. Show only the image, no frame or mat.
- The jpeg file must include the title of the painting and the size.
- Label your CD using a permanent marker with your name and title of paintings.
- A hard copy print of your images must accompany CD.
