## Eligibility

Original work only, completed without supervision from idea to execution, within the past 5 years

No works previously entered in GCVAA show

GCVAA reserves the right to refuse any inappropriate or inadequately framed artwork, or artwork misrepresented by entry slide/digital imagery.

## Entry Procedure

Submit up to four digital images.

Entry fee is \$35/non-members;

\$25/members (as of 12/31/11) or workshop participant. Make checks payable to GCVAA.

## Entering the competition grants

**GCVAA permission to publish the images of accepted paintings for publicity on the web and in print.**

## Guidelines for Digital Submissions

- **Digital entries must be in jpeg format on a CD. Set camera resolution at 300 dpi.**
- **Image size should be no larger than 6" in either direction.**
- **Image must be oriented correctly. Show only the image, no frame or mat.**
- **The jpeg file must include the artist's name, title of the painting, and the image size: smithj.title.24x36**
- **Label your CD using a permanent marker with your name and title of paintings.**
- **A 4x6 photo of your images must accompany CD.**

**Photos and CD will not be returned.**
